## 2013-2014 FEDERAL TEACH GRANT APPLICATION

**Important:** The first TEACH Grants will be awarded to eligible students for the 2013-2014 school year. Eligibility and award is based on term enrollment. Students will be reviewed every term to ensure GPA and program eligibility. This form must be received in our office at least 30 days prior to your last date of enrollment during the **2013-14** academic year.

**Directions:** Complete this form to be considered for the federal Teacher Education Assistance for College and Higher Education (TEACH) Grant program. The TEACH Grant provides up to \$4,000 per year (\$16,000 total for 4-year undergraduate programs, and \$8,000 total for graduate programs) in grants to students who commit to:

1. Teach full-time;
2. In high-need subject areas;
3. For at least four out of the first eight years teaching;
4. At schools that serve students from low-income families.

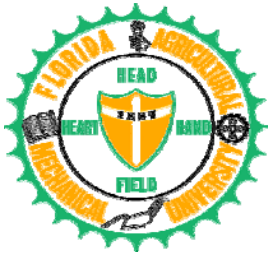
**If the commitment is not fulfilled, the grant is permanently converted to a loan to be repaid by the recipient.** The loan is a Ford Federal Direct Unsubsidized Loan with interest calculated from the time of the grant disbursement.
