**SUMMARY OF REGULATION:** This amendment reflects the change in the University's Organizational structure at the executive level, with the inclusion of the Chief Operating Officer, who serves as second in command to the University President. The remaining order of succession is appropriately adjusted as a result.

AUTHORITY FOR REGULATION: Article IX, Section 7, Florida Constitution, Board of Governors Regulation 1.001.

## Florida A&M University Regulation

## 1.017 Succession to Administrative Authority and Responsibility of the President.

In the absence or disability of the President, the Executive Vice President and Chief
Operating Officer shall assume all administrative authority and responsibility of the President.
(1)(2) In the absence or disability of the President and the Executive Vice President and Chief
Operating Officer, the Provost and Vice President for Academic Affairs shall assume all the administrative authority and responsibility of the President.

(2)(3) In the absence or disability of the President, Executive Vice President and Chief Operating Officer and the Provost and Vice President for Academic Affairs, the Vice President for Finance and Administration shall assume all the administrative authority and responsibility of the President. (3)(4) In the absence or disability of the President, Executive Vice President and Chief Operating Officer, Provost and Vice President for Academic Affairs and the Vice President for Finance and Administration, the Vice President for Student Affairs shall assume all the administrative authority and responsibility of the President.

(4)(5) In the absence or disability of the President, <u>Executive Vice President and Chief Operating</u> Officer, Provost and Vice President for Academic Affairs, Vice President for Finance and Administration and the Vice President for Student Affairs, the Vice President for Audit and <u>Compliance</u> shall assume all the administrative authority and responsibility of the President. (5)(6) In the absence or disability of the President, <u>Executive Vice President and Chief Operating</u> Officer, Provost and Vice President for Academic Affairs, Vice President for Finance and Administration, Vice President for Student Affairs and the Vice President for Audit and Compliance, the Vice President for Sponsored Research shall assume all the administrative authority and responsibility of the President.

(6)(7) In the absence or disability of the President, <u>Executive Vice President and Chief Operating</u> Officer, Provost and Vice President for Academic Affairs, Vice President for Finance and Administration, Vice President for Student Affairs, Vice President for Audit, and Compliance and the Vice President for Sponsored Research, the Vice President for University Advancement shall assume all the administrative authority and responsibility of the President.

(7)(8) The responsibility for coordination of the succession will rest with the Assistant to the President.
