GRADUATE DEGREE-SEEKING students must meet the following requirements:

A. At least one of the following:

Earned a "B" (3.0) average or better for the last 60 semester hours (or equivalent) of undergraduate work attempted, and/or

B. A combined score (verbal and quantitative) of 1000 or better on the Graduate Record Examination (GRE), or a minimum score of 600 on the Graduate Management Admission Test (GMAT)

GRADUATE DEGREE-SEEKING students must submit the following:

A. Official undergraduate transcript(s) from all institutions attended

B. GRE or GMAT Scores

While an extremely small number of applicants, who are deficient in the aforementioned criteria may be admitted provisionally, applicants should be cognizant that admission to graduate studies is primarily determined by their ability to fulfill the above requirements (Check with the appropriate college, school or institution for additional criteria).

Students who do not wish to pursue a degree or those who do not meet the requirements for admission to a graduate program may attend Florida Agricultural and Mechanical University (FAMU) under the non-degree seeking POST BACCALAUREATE classification. Individuals admitted to this category may enroll in graduate courses subject to availability of class space and approval of the college, school or institute concerned.

The applicant must submit official transcripts of his/her academic record from each college or university attended. The transcript(s) must provide evidence of the applicant's bachelor's degree. Unofficial transcripts in the possession of applicants are not acceptable.

It is the applicant's responsibility to make arrangements to take the GRE or the GMAT. The Educational Testing Service (ETS) will mail the official test results directly to the Admissions Office. Foreign applicants whose native language is not English must also take the Test of English as a Foreign Language (TOEFL) and have their scores submitted by ETS. The GMAT is required for admission to the School of Business and Industry.

Health records are required of students registered for six semester hours or more (nine hours are considered as full-time for fee purposes). Therefore, if an applicant indicates full-time (6 semester hours) on his/her application, a Medical Records Form will be mailed to the applicant. The completed Medical Records Form should be sent directly to the Student Health Clinic Office.

Questions regarding housing and/or Financial aid should be directed to the appropriate offices.

STATE UNIVERSITY SYSTEM OF FLORIDA - INFORMATION FOR RESIDENCE CLASSIFICATION

A resident affidavit must be filed by each student applying for admission to any SUS institution in Florida
The basic rule of Florida residence states that a **Florida student** is a person (or if the person is less than 18 years of age, the parent or legal guardian) who has domicile in and has resided in the state of Florida for at least twelve (12) consecutive months immediately preceding the first day of classes of the academic term for which the classification is to take effect.

In determining eligibility for classification as a **Florida student** the university will take into consideration actions taken by the student (or if applicable, the parent or guardian) which show that residence of 12 months has been established in the State of Florida. Such actions should include registering to vote in Florida, obtaining a Florida Driver's License, registering motor vehicles in Florida, and any other action which shows that permanent residence has been established in this state. If such actions have not been taken, an explanation must accompany the affidavit.

The following are special categories and are treated as exceptions to the basic rule indicated above. If you feel there is a possibility that you might qualify under one of these categories, indicate that category below and complete the affidavit. Detailed documentation as indicated for the category must be provided.

- _____ Members of the Armed Services stationed in Florida on active duty, their spouse and dependent students. (Provide a copy of current orders, plus proof of marriage and/or dependency if applicable.)
- _____ Veterans of the Armed Forces with 20 or more years of active service who move to Florida within one year of retirement, the spouse and dependent students. (Provide copy of DD-214, proof of move to Florida within one year of retirement, plus proof of marriage and/or dependency if applicable.)

- _____ Full time school teachers and faculty of community colleges under current teaching contract in Florida, their spouses and dependent students. (Verification of full-time employment from school, plus proof of marriage and/or dependency if applicable.)
- _____ Full-time faculty, administrative and professional, and career service employees of the State University System, their spouses and dependent students. (Provide letter from institution's Director of Personnel reflecting status as full-time employee, plus proof of marriage and/or dependency if applicable.)
- _____ Florida residents living in the Panama Canal Zone who have not established residence elsewhere, their spouses and dependent students. (Provide proof of previous Florida residence, plus proof of marriage, and/or dependency if applicable.)
- _____ Florida residents who had residency interrupted by service in the armed forces , Peace Corps or other government-sponsored volunteer organization. (Military service: Provide proof of home of record, periods of actual residence in Florida , date and state from which you last entered active military service, date and state of last voter registration. Peace Corps; etc: Provide letter certifying participation in program and proof of previous Florida residency.)
