Approval of August 6, 2020, DSO Committee Meeting Minutes

Trustee Lawson motioned for approval; seconded by Trustee Harper. The motion passed, unanimously.

Dr. Friday-Stroud provided updates on Divisional Activities

A. DSO Updates

1. FAMU Foundation

- The Investment Portfolio balance on June 30, 2020, is over \$123.5M
- The Endowment balance on June 30, 2020, is over \$95M.

2. FAMU National Alumni Association

- The Annual Alumni Convention planned for November of 2020 in Orlando has been cancelled due to the pandemic.
- A Founder's Day Fundraising Campaign will be launched on October 3, 2020.
- An Alumni Virtual Town Hall Meeting was held regarding the Rattler Reopening.

3. FAMU Rattler Boosters

- They have embarked on a fundraising goal of \$159K to replace the roof on the Galimore-Powell Field House.
- Rolled out two new Rattler Boosters Membership levels.
- They will reschedule the Virtual All Sports Kick-Off Fundraising event due to the pandemic.

B. FY 2019-2020 University Advancement Updates

- President Larry Robinson and Industry Cluster Chair, Cheryl Harris, will be hosting a Virtual Symposium featuring the Chairman of the Microsoft Board, John Thompson, on September 23 at 4 p.m.
- \$787K raised as of August 28.

C. EAB Presentation

- Mr. Tom Zydel, Senior Strategic Leader with EAB, presented the FAMU update. EAB is University Advancement's alumni and friends fundraising partner.
- Have seen a significant increase in the giving rate.



Mr. Zydel stated that we need to continue showing our outcomes and how their donations improve
those outcomes, continue thanking donors in every way possible, and continue building a culture of
giving early in students' matriculation.

- The Investment Portfolio balance at 9/30/20 is \$127,135,574.
- The Endowment balance at 9/30/20 is \$96,629,373.



2. FAMU National Alumni Association (NAA)

- The Office of Alumni Affairs (OAA) and the FAMU NAA produced a 10-hour event on October 3 celebrating the 133rd birthday of our historic FAMU.
 - President Larry Robinson, leadership, and student leaders participated in support of FAMU Athletics.
 - More than 500K in scholarship dollars have been generated over the fiscal year.
 - Leadership workshops focused on legislative advocacy amid the pandemic and highlighted creative strategies with alumni ambassadors who assist the University with student recruitment in this COVID 19 environment.
- OAA and the FAMU NAA produced a heartwarming salute to America's veterans while honoring retired Rattler alumni who adorn the uniform as well.
 - Five members of the Rattlers In Arms were honored and presented the Brigadier General Leroy Bell Military Leadership Award for their outstanding generosity in raising scholarship dollars toward enhancing the academic success of our students.
 - They were acknowledged last year for their check presentation on the football field at the military appreciation game for their supportive strides, and on the evening of the awards program on Veteran's Day, the group presented another check for \$30,000 in support of FAMU.
