## Purpose

The purpose of this meeting is to amicably resolve and execute the Florida A&M University Board of Trustees (BOT) decision to restore game day parking and multimedia assets back to the Department of Athletics pursuant to the **Board of Trustees Policy Number 2005-18**; **Sections 1001.74** and **1001.75**, **Florida Statutes**.

## Board of Trustees Policy Number 2005-18; Sections 1001.74 and 1001.75, Florida Statutes

**Section 2 – Finances** (1) All booster organizations or club activities, i.e., concessions, parking, program sales, fundraising activities, etc., shall be conducted through the University's Athletic Department, to ensure adherence to the University's accounting policies and controls. (2) All funds received and expended from booster accounts must be deposited into a University account and subject to accounting in the University's Controller/Budget Office.

Status – Booster collected funds have not been deposited into University accounts

**Section 3 – Fundraising Activities of Athletic Boosters** Upon the conclusion of any fundraising activity, a post activity report of the fundraising activity, including items sold/donated, list of participants, list of donors and amount of donations, etc., shall be provided to the President or the President's designee.

<u>Status</u> – Boosters have not provided a complete list of participating donors, items sold or amount of donations.

#### NCAA Policy

The Principles of Institutional Control and Rules Compliance set forth in Articles 2 and 6 of the NCAA Constitution require that NCAA member institutions monitor the activities of outside entities, organizations, and any other representatives of the institution's athletics interests that promote the institution's intercollegiate athletics program. Rattler Boosters fits squarely within these NCAA definitions, and the requested information is necessary in order for FAMU Athletics to monitor the organization's compliance with NCAA legislation governing institutional control, compensation and remuneration for athletics personnel (Bylaw 11), recruiting activities and the use of recruiting funds (Bylaw 13), awards and benefits (Bylaw 16), and other areas of NCAA rules, including the enforcement provisions that require member institutions to investigate potential NCAA rules violations and report any such violations (Bylaw 19).

It is our hope that these records and financial transactions will be furnished prior to July 6, 2016, so that FAMU Athletics (and Rattler Boosters) can meet all obligations required by the Florida A&M University Board of Trustees (BOT) and NCAA legislation. Failure to do so is a violation of University Policy, Florida Statute, and NCAA compliance that could result in disassociation as a Direct Support Organization (DSO) in addition to legal action.
