NOTICE OF PROPOSED AMENDED REGULATION

DATE: April 23, 2007

REGULATION CHAPTER TITLE: Student Affairs

REGULATION TITLE AND NUMBER: Health Service (2.008)

SUMMARY OF REGULATION: The amended Regulation specifies that the health fee will be expended to cover operational expenses, personnel, general programs, and other services related to the Student Health Service unless provided otherwise by law.

AUTHORITY FOR REGULATION: Article IX, Florida Constitution, Board of Governors Regulation Development Procedure dated July 21, 2005, and Section 1009.24, Florida Statutes.

UNIVERSITY OFFICIAL INITIATING THIS REGULATION: Dr. Vincent G. June, Vice President for Student Affairs.

FULL TEXT OF THE PROPOSED AMENDED REGULATION: The full text of the proposed amended regulation follows:

Regulation of Florida A&M University



2.008 Health Service.

(1) A Student Health Fee is automatically assessed at the time of registration for each student who is registered for six (6) or more semester hours of credit. Students who register for less than six (6) semester hours have the option to pay a health fee and receive health services.

(2) The health fee paid each semester entitles the student to attend the Student Health Service and receive professional medical care as often as he or she chooses. The fee will be used to cover the costs of operational expenses, personnel, general programs and other services related to the Student Health Service unless provided otherwise by law. The fee does not pay for durable medical supplies, which include but are not specifically limited to crutches, sprints, ice packs, etc., lab work, X-rays, or medication ordered by the Student Health Service. Florida A & M University students who have paid a health fee are eligible for services in the Student Health Service during the semester for which they are registered. Presentation of a valid “Rattler” I. D. card is required.

(3) If the services of an off-campus medical facility are needed, the student is responsible for the bill incurred from the off-campus medical facility.

(4) If off-campus specialized treatment is needed, the student is responsible for transportation to the off-campus medical facility.
