JOB OUTLOOK

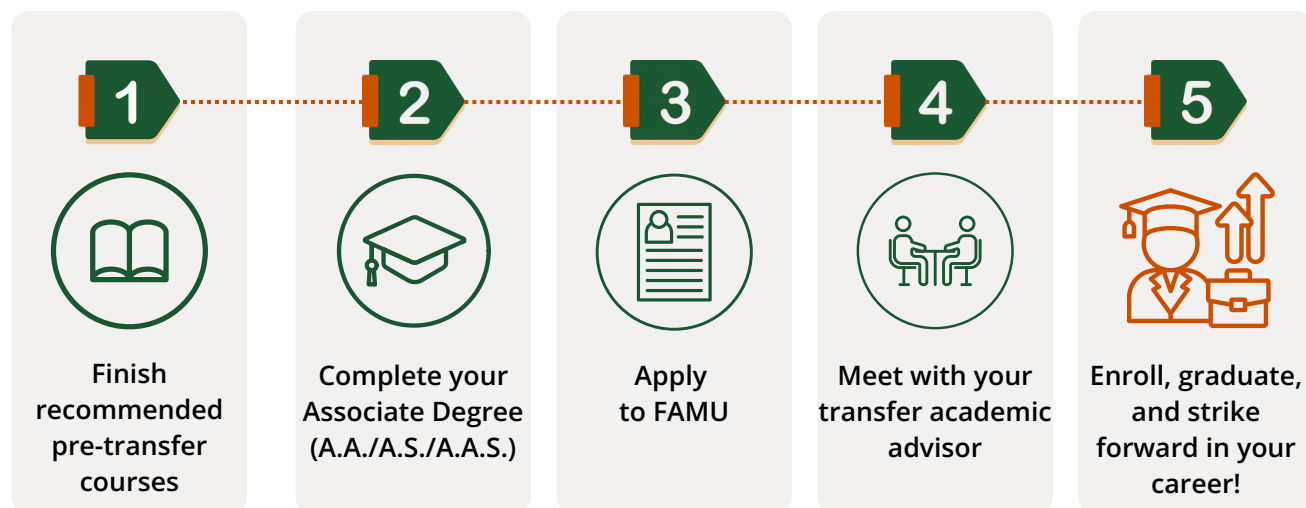
