Homicide	<ul> <li>Murder/non-negligent manslaughter: the willful (non-negligent) killing of one human being by another</li> <li>Negligent Manslaughter: the killing of another person through gross negligence</li> </ul>			
Sex Offenses	<ul> <li>Sex offenses: Any sexual act directed against another person without the consent of the victim, including instances where the victim is incapable of giving consent</li> <li>Rape: The penetration, no matter how slight, of the vagina or anus with any body part or object, or oral penetration by a sex organ of another person, without the consent of the victim</li> <li>Fondling: The touching of the private body parts of another person for the purpose of sexual gratification, without the consent of the victim is incapable of giving consent because of his/her age or because of his/her temporary or permanent mental incapacity</li> <li>Incest: Sexual intercourse between persons who are related to each other within the degrees wherein marriage is prohibited by law</li> <li>Statutory Rape: Sexual intercourse with a person who is under the statutory age of consent</li> </ul>			
Robbery	Taking or attempting to take anything of value from the care, custody, or control of a person or persons by force or threat of force or violence and/or by putting the victim in fear			
Aggravated Assault	Unlawful attack by one person upon another for the purpose of inflicting severe or aggravated bodily injury			
Burglary	Unlawful entry of a structure to commit a felony or a theft			
Motor Vehicle Theft	The theft or attempted theft of a motor vehicle			
Arson	Willful or malicious burning or attempt to burn with or without intent to defraud a dwelling house, public building, motor vehicle or aircraft, personal property of another, etc.			
Dating Violence	Violence committed by a person who is or has been in a social relationship of a romantic or intimate nature with the victim; and where the existence of such a relationship shall be determined based

#### **Geography Definitions**

#### On campus:

- any building or property owned or controlled by an institution within the same reasonably contiguous geographic area and used by the institution in direct support of, or in a manner related to, the institution's educational purposes, including residence halls; and
- any building or property that is within or reasonably contiguous to the area identified in paragraph (1) of this definition, that is owned by the institution but controlled by another person, is frequently used by students, and supports institutional purposes (such as food or other retail vendors)

#### Non-campus building or property:

- any building or property owned or controlled by a student organization that is officially recognized by the institution; or
- any building or property owned or controlled by an institution that is used in direct support of, or in relation to, the institution's educational purposes, is frequently used by students, and is not within the same reasonably contiguous geographic area of the institution

#### **Public property:**

• all public property, including thoroughfares, streets, sidewalks, and parking facilities, that is within the campus, or immediately adjacent to and accessible from the campus
