Return the signature page with the \$200 non-refundable advance payment to University Housing, Florida A&M University, 1596 Gibbs Hall Trail, Tallahassee, Florida 32307-6000. Student keeps the Housing Agreement Terms and Conditions. To cancel a room assignment, students must submit a cancellation form.
