Composed of talented student vocalists, the choir performs a diverse repertoire, including classical, gospel, spirituals, and contemporary choral works. The choir not only enriches the cultural and artistic landscape of FAMU but also serves as an ambassador of the university, sharing its legacy of excellence through music.		

Whereas,	The FAMU Concert choir is seeking, to become better equip, with resources that will improve productivity, participation, and musicality.	
Whereas,	Receiving funds would greatly benefit the FAMU Concert Choir by enhancing its ability to perform at a high level and represent the university on larger stages.
