Whereas,	the Senate seeks to continue fostering awareness, communication, and meaningful connections between senators and the student body, with the goal of ensuring that students feel empowered, informed, and supported by tangible resources provided through the Senate		
Therefore,	we propose that the Senate move its meeting location to the Grand Ballroom for one session each semester, transforming the event into a student-centered engagement opportunity. This would provide students with a chance to interact directly with senators, learn how a Senate meeting is conducted, and engage in meaningful dialogue about the work being done on their behalf.		

Article 5- Business of the Senate

5.1.1 Regular Senate Sessions

The Senate shall have regular sessions every Monday of each month except in the event of a university holiday, conflicting Student Government Association event, or an unforeseen circumstance (I.e natural disaster) in which cases the Senate will meet on the following Wednesday. All Senate Sessions shall be recorded via video, recording device or any other method of recording deemed appropriate by the Senate President. Each semester, the Senate is required to host at least one session in the Grand Ballroom to provide more students with the opportunity to attend in person, engage with the proceedings, and stay informed about Senate matters.
